

BOARD OF ADJUSTMENT

Authority to Establish: G. S. 153A-345

Pertinent Rules: Must comply with the Open Meetings Law

Composition of the Board: The Union County Board of Commissioners adopted a Text Amendment to the Union County Land Use Ordinance on March 16, 2009, establishing a Board of Adjustment consisting of five regular members and two alternates, all appointed by the Board of Commissioners. All regular members and alternates shall reside within the County. Board of adjustment regular members and alternates shall be appointed for three-year staggered terms, but both regular members and alternates may continue to serve until their successors have been appointed. In order to achieve staggered terms upon initial appointment following establishment of the board of adjustment, (i) two regular members shall be appointed for a term of three years; (ii) two regular members and one alternate shall be appointed for a term of two years; and (iii) one regular member and one alternate shall be appointed for a term of one year.

Regular and alternate members of the board of adjustment shall only be considered for appointment after submitting a completed county service application and conflict of interest disclosure form to the Clerk to the Board of Commissioners.

Regular and alternate members of the board of adjustment shall not serve on any of the following Union County boards and committees during their term: the Planning Board, the Parks and Recreation Advisory Board, the Joint Historic Preservation Commission, the Library Board of Trustees, the Agricultural Advisory Board, the Public Works Advisory Board, and the Board of Equalization and Review; nor shall regular or alternate members serve on the board of directors of Union County Partnership for Progress, a North Carolina nonprofit corporation.

COMPENSATION: \$30 per meeting
